On behalf of my employer, REI, the Outdoor Industry Association (of which REI is a member), and in my role as a board member for the National Parks Conservation Association (NPCA), I have had occasional meetings with members of Congress and officials in both the Bush and Obama Administrations on matters generally relating to public lands stewardship, recreation, and conservation.

Between 2005 and the present, as the CEO of REI and on behalf of the Outdoor Industry Association and the Retail Industry Leaders Association, I have also participated in multiple meetings on Capitol Hill regarding retail and trade related issues. On occasion, I have joined with other outdoor and retail industry leaders in signing letters of support for legislation at both a federal and state level.

I have traveled to the Washington State Capitol in Olympia in support of funding for public lands and higher education, and as a board member and former president of the Mountains to Sound Greenway Trust, I have met with many city, county, State and federal officials regarding lands in the Greenway and their thoughtful stewardship and economic development.

From 2009-2011 I served on the National Parks Second Century Commission and participated in various meetings to discuss the Commission report's contents and recommendations.

Each nominee coming before the Committee on Energy and Natural Resources shall agree to:

- (1) Abide by the recusal requirements imposed by federal conflict of interest laws and the Standards of Ethical Conduct for Employees of the Executive Branch;
- (2) Seek the advice of his or her designated agency ethics officer before proceeding whenever faced with a situation that may give rise to an actual or apparent conflict of interest; and
- (3) Adhere to the principles of ethical conduct and avoid any actions crating the appearance of violating the Standards of Ethical Conduct for Employees of the Executive Branch.
