3	SECTION 1. SHORT TITLE.
4	This Act may be cited as the "Camp Nelson National
5	Monument Act".
6	SEC. 2. DEFINITIONS.
7	In this Act:
8	(1) Map.—The term "Map" means the map en-
9	titled "Camp Nelson National Monument
10	Nicholasville, Kentucky", numbered 532/144,148,
11	and dated September 2018.

1	(2) MONUMENT.—The term "Monument"
2	means the Camp Nelson National Monument estab-
3	lished by section $3(a)(1)$ .
4	(3) Secretary.—The term "Secretary" means
5	the Secretary of the Interior, acting through the Di-
6	rector of the National Park Service.
7	SEC. 3. ESTABLISHMENT OF CAMP NELSON NATIONAL
8	MONUMENT.
9	(a) Establishment.—
10	(1) In general.—Subject to paragraph (2),
11	there is established as a unit of the National Park
12	System the Camp Nelson National Monument in the
13	State of Kentucky to preserve, protect, and inter-
14	pret, for the benefit of present and future genera-
15	tions, the nationally significant historic resources of
16	Camp Nelson and the role of Camp Nelson in the
17	Civil War, Reconstruction, and African American
18	history and civil rights.
19	(2) Sufficient land or interests.—The
20	Monument shall not be established until after the
21	date on which the Secretary has determined that
22	sufficient land or interests in land have been ac-
23	quired within the boundary of the Monument to con-
24	stitute a manageable unit.

1	(b) Boundary.—The boundary of the Monument
2	shall be the boundary generally depicted on the Map.
3	(c) AVAILABILITY OF MAP.—The Map shall be on file
4	and available for public inspection in the appropriate of-
5	fices of the National Park Service.
6	(d) Acquisition Authority.—The Secretary may
7	only acquire any land or interest in land located within
8	the boundary of the Monument by—
9	(1) donation;
10	(2) purchase from a willing seller with donated
11	or appropriated funds; or
12	(3) exchange.
13	(e) Administration.—
14	(1) In General.—The Secretary shall admin-
15	ister the Monument in accordance with—
16	(A) this Act; and
17	(B) the laws generally applicable to units
18	of the National Park System, including—
19	(i) section 100101(a), chapter 1003,
20	and sections 100751(a), 100752, 100753,
21	and 102101 of title 54, United States
22	Code; and
23	(ii) chapter 3201 of title 54, United
24	States Code.
25	(2) Management plan.—

1	(A) IN GENERAL.—Not later than 3 years
2	after the date on which funds are first made
3	available to the Secretary to prepare a general
4	management plan for the Monument, the Sec-
5	retary shall prepare a general management plan
6	for the Monument in accordance with section
7	100502 of title 54, United States Code.
8	(B) Submission to congress.—On com-
9	pletion of the general management plan, the
10	Secretary shall submit to the Committee on
11	Natural Resources of the House of Representa-
12	tives and the Committee on Energy and Nat-
13	ural Resources of the Senate the general man-
14	agement plan.
15	(f) No Buffer Zones.—
16	(1) In General.—Nothing in this Act, the es-
17	tablishment of the Monument, or the management of
18	the Monument creates a buffer zone outside of the
19	Monument.
20	(2) ACTIVITY OR USE OUTSIDE MONUMENT.—
21	The fact that an activity or use can be seen, heard,
22	or detected from within the Monument shall not pre-
23	clude the conduct of the activity or use outside of
24	the Monument.
