3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Korean War Veterans

5 Memorial Wall of Remembrance Act”.

6 **SEC. 2. WALL OF REMEMBRANCE.**

7 (a) AUTHORIZATION.—

8 (1) IN GENERAL.—Notwithstanding section

9 8908(e) of title 40, United States Code, the Korean

10 War Veterans Memorial Foundation, Inc., may con-

1 construct a Wall of Remembrance at the site of the Ko-
2 rean War Veterans Memorial.

3 (2) REQUIREMENT.—

4 (A) IN GENERAL.—The Wall of Remem-
5 brance shall include a list of names of members
6 of the Armed Forces of the United States who
7 died in the Korean War, as determined by the
8 Secretary of Defense, in accordance with sub-
9 paragraph (B).

10 (B) CRITERIA; SUBMISSION TO THE SEC-
11 RETARY OF THE INTERIOR.—The Secretary of
12 Defense shall—

13 (i) establish eligibility criteria for the
14 inclusion of names on the Wall of Remem-
15 brance under subparagraph (A); and

16 (ii) provide to the Secretary of the In-
17 terior a final list of names for inclusion on
18 the Wall of Remembrance under subpara-
19 graph (A) that meet the criteria estab-
20 lished under clause (i).

21 (3) ADDITIONAL INFORMATION.—The Wall of
22 Remembrance may include other information about
23 the Korean War, including the number of members
24 of the Armed Forces of the United States, the Ko-
25 rean Augmentation to the United States Army, the

1 Republic of Korea Armed Forces, and the other na-
2 tions of the United Nations Command who, in re-
3 gards to the Korean War—

4 (A) were killed in action;

5 (B) were wounded in action;

6 (C) are listed as missing in action; or

7 (D) were prisoners of war.

8 (b) **COMMEMORATIVE WORKS ACT.**—Except as pro-
9 vided in subsection (a)(1), chapter 89 of title 40, United
10 States Code (commonly known as the “Commemorative
11 Works Act”), shall apply.

12 (c) **NO FEDERAL FUNDS.**—No Federal funds may be
13 used to construct the Wall of Remembrance.
