3 (a) AUTHORIZATION OF APPROPRIATIONS.—Section
4 5 of the Reclamation Safety of Dams Act of 1978 (43
5 U.S.C. 509) is amended—

6 (1) in the first sentence, by striking “necessary
7 and, effective” and all that follows through “herein,”
8 and inserting “necessary”;

9 (2) in the proviso—

10 (A) by striking “\$1,250,000” and inserting
11 “\$20,000,000”; and

12 (B) by striking “Congress” and inserting
13 “Committee on Natural Resources of the House

1 of Representatives and the Committee on En-
2 ergy and Natural Resources of the Senate”;
3 and

4 (3) by adding at the end the following: “For
5 modification expenditures between \$1,800,000 and
6 \$20,000,000 (October 1, 2013 price levels), the Sec-
7 retary of the Interior shall, at least 30 days before
8 the date on which the funds are expended, submit
9 written notice of the expenditures to the Committee
10 on Natural Resources of the House of Representa-
11 tives and the Committee on Energy and Natural Re-
12 sources of the Senate that provides a summary of
13 the project, the cost of the project, and any alter-
14 natives that were considered.”.

3 **SECTION 1. AMENDMENTS TO THE RECLAMATION SAFETY**
4 **OF DAMS ACT OF 1978.**

5 (a) **AUTHORIZATION OF APPROPRIATIONS.**—Section
6 5 of the Reclamation Safety of Dams Act of 1978 (43
7 U.S.C. 509) is amended in the first sentence by striking
8 “necessary and, effective” and all that follows through
9 “herein” and inserting “necessary”.

1 (b) CONFORMING AMENDMENT.—Section 4(c) of the
2 Reclamation Safety of Dams Act of 1978 (43 U.S.C.
3 508(c)) is amended in the matter preceding paragraph (1)
4 by striking “additional”.
