- 2 SECTION 1. GENERAL AUTHORITY.
- 3 In carrying out its powers, duties, and functions
- 4 under the Standing Rules of the Senate, in accordance
- 5 with its jurisdiction under Rule XXV of the Rules, includ-
- 6 ing holding hearings, reporting the hearings, and making
- 7 investigations as authorized by paragraphs 1 and 8 of
- 8 Rule XXVI of the Standing Rules of the Senate, the Com-

- 1 mittee on Energy and Natural Resources (referred to in
- 2 this resolution as the "Committee") is authorized for the
- 3 period beginning October 1, 2013, and ending September
- 4 30, 2014, and for the period beginning October 1, 2014,
- 5 and ending February 28, 2015, in its discretion—
- 6 (1) to make expenditures from the contingent
- 7 fund of the Senate;
- 8 (2) to employ personnel; and
- 9 (3) with the prior consent of the government
- department or agency concerned and the Committee
- on Rules and Administration, to use on a reimburs-
- able or nonreimbursable basis the services of per-
- sonnel of any such department or agency.

- 15 (a) Initial Period.—The expenses of the Com-
