## A BILL

To reauthorize and update certain provisions of the Secure Water Act.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "SECURE Water
- 5 Amendments Act of 2014".
- 6 SEC. 2. AUTHORIZED ACTIVITIES; ELIGIBILITY; AUTHOR-
- 7 IZATION OF APPROPRIATIONS.
- 8 (a) IN GENERAL.—Section 9504 of the Omnibus
- 9 Public Land Management Act of 2009 (42 U.S.C. 10364)
- 10 is amended—

1	(1) in subsection (a)—
2	(A) in paragraph $(1)(H)$ —
3	(i) in clause (i), by striking "or" at
4	the end;
5	(ii) in clause (ii), by striking the pe-
6	riod and inserting "; or"; and
7	(iii) by adding at the end the fol-
8	lowing:
9	"(iii) to plan for or address the im-
10	pacts of drought."; and
11	(B) in paragraph $(2)(\Lambda)$ —
12	(i) by striking "; and" and inserting
13	"; or";
14	(ii) by striking "(A) be located within
15	the States" and inserting the following:
16	"(A) be located in—
17	"(i) the States"; and
18	(iii) by adding at the end the fol-
19	lowing:
20	"(ii) the State of Hawaii; and"; and
21	(2) in subsection (e), by striking "There is"
22	and all that follows through "\$200,000,000" and in-
23	serting "There are authorized to be appropriated
24	such sums as are necessary to carry out this section
25	for each of fiscal years 2015 through 2023".

1	SEC. 3. AUTHORIZATION OF APPROPRIATIONS FOR NA-
2	TIONAL WATER AVAILABILITY AND USE AS-
3	SESSMENT PROGRAM.
4	Section 9508(e)(2) of the Omnibus Public Land Man-
5	agement Act of 2009 (42 U.S.C. 10368(e)(2)) is amended
6	by striking "\$12,500,000 for the period of fiscal years
7	2009 through 2013" and inserting "such sums as are nec-
8	essary for the period of fiscal years 2014 through 2023".
