- 16 "(B) In the case of a project not approved before
- 17 June 22, 2005, and for which the final environmental im-
- 18 pact statement was issued more than 15 days before the
- 19 date of enactment of this subsection, this paragraph shall
- 20 apply, except that the Governor of the State shall submit
- 21 the approval or disapproval of the Governor not later than
- 22 30 days after the date of enactment of this subsection,
- 23 or approval shall be conclusively presumed. If the Gov-
- 24 ernor disapproves the project within that period, neither
- 25 the Commission nor any other Federal agency shall take

- 1 any further action to approve the project or the construc-
- 2 tion or operation of the project.".
